REGIONAL DEVELOPMENT

- Regional Development Agency opened in Comrat in 2016
- √ 18 local projects in the framework of the National Programme "European village"
 for the development of villages and towns in Gagauzia were approved.
- 25 project concepts for infrastructure development, energy efficiency, water supply, development of innovative forms of activities in agriculture.
- √ 3 regional sectorial programmes.
- √ 31 donors involved.
- √ reconstruction of the road L-639 Ferapontievca Avdarma Chiriet Lunga: 2,5 km.
- √ 3 projects financed by the National Regional Development Fund.
- √ 5 donor-funded projects.
- Development and connection to the utility infrastructure and access roads of the industrial park in comrat. 3250 m. water supply networks; 2 tanks with the capacity of 300 m³ were built; 840 m. sewer networks and a sewage treatment plant; 1080 m. gas networks; 6400 m. power networks.
- √ 1 industrial Park = 1100 jobs.
- Reconstruction of the access road to the business area (incubator) of Ciadar-Lunga, the number of enterprises increased from 15 to 21 and the number of employments threefold.
- The formula for allocating funds for road repair was revised and subsequently applied for the ATU Gagauzia, and then applied at the national level from 2017. From the Road Fund for the repair of local roads in the ATU Gagauzia in the course of 5 years about 250 million Lei were allocated.





CONSULTATION MECHANISMS AND TRANSPARENCY OF THE DECISION-MAKING PROCESS

- A new mechanism for monitoring national draft laws developed by the People's Assembly of Gagauzia in 2017.
- Mechanism for mutual consultations on draft normative acts in the course of a decision-making process approved by the PWG in 2022.



- ✓ The Parliament of the Republic of Moldova, the central public authorities will consult the People's Assembly/ Executive Committee of Gagauzia on issues related to the status or competences of the ATU Gagauzia in course of considering draft modifications to the national legislation.
- ✓ Public authorities of the ATU Gagauzia will consult central public authorities on various issues in accordance with the competences of the Autonomy.
- * This result was reflected in the Report of the European Commission on the progress of Moldova towards accession negotiations to the European Union. The Report was published on November 8, 2023.
- Representatives of the ATU Gagauzia's authorities were appointed as members of national councils for the administration of national funds: the Road Fund and the Regional Development Fund.
